




- Fall Creek Trail extension connecting Monon to Central Ave.:
   \$1.25 million
- Illinois St Bridge over Fall Creek:
   \$3.5 million rehab
- Meridian St Bridge over Fall Creek:
   \$2.5 million rehab
- Long Term Control Plan for Sewer overflows: \$1.7 billion
